Conversion of shares

According to Husqvarna AB's articles of association, owners of Class A shares have the right to have such shares converted to Class B shares. Conversion reduces the total number of votes in Husqvarna AB. When such a conversion has occurred, the company is obligated by the Act on Trading in Financial Instruments to disclose any such change.

In October 2017, at the request of shareholders, 73,200 Class A shares were converted to Class B shares. The total number of votes thereafter amounts to 159,541,051.1.

The total number of registered shares in the company amounts to 576,343,778 shares of which 113,229,637 are Class A shares and 463,114,141 are Class B shares.
