Conversion of shares

According to Husqvarna AB's articles of association, owners of Class A shares have the right to have such shares converted to Class B shares. Conversion reduces the total number of votes in Husqvarna AB. When such a conversion has occurred, the company is obligated by the Act on Trading in Financial Instruments to disclose any such change.

In July 2019, at the request of shareholders, 150 Class A shares were converted to Class B shares. The total number of votes thereafter amounts to 158,449,628.3.

The total number of registered shares in the company amounts to 576,343,778 shares of which 112,016,945 are Class A shares and 464,326,833 are Class B shares.

This information is such that Husqvarna AB must disclose in accordance with the Financial Instruments Trading Act. The information was submitted for publication on July 31, 2019, at 09:00 CET.
