Conversion of shares

According to Husqvarna AB's articles of association, owners of Class A shares have the right to have such shares converted to Class B shares. Conversion reduces the total number of votes in Husqvarna AB. When such a conversion has occurred, the company is obligated by the Act on Trading in Financial Instruments to disclose any such change.

In December 2021, at the request of shareholders, 204,207 Class A shares were converted to Class B shares. The total number of votes thereafter amounts to 157,430,682.5.

The total number of registered shares in the company amounts to 576,343,778 shares of which 110,884,783 are Class A shares and 465,458,995 are Class B shares.
